

Information on the processing of the personal details of visitors who consult the website of the Foundation pursuant to articles 13 and 14 of Regulation (EU) no. 2016/679 (GDPR, hereinafter the “Regulation”)

The Carlo Acutis Foundation (hereinafter the “Foundation” or the “Data Controller”), a non-profit organisation with registered office in Via Don Minzoni 14 – 10121 Turin, is aware of the importance of protecting privacy and individual rights. Since users’ personal data may circulate to a considerable extent on internet, the foundation is seriously committed to observing the rules of conduct – in keeping with Regulation (EU) no. 679/2016 of the European Parliament and the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and the free movement of such data – that guarantee safe, controlled, confidential web browsing.

Pursuant to the GDPR, this disclosure describes how the Foundation processes the personal data of visitors/users who consult the website of the Foundation, which can be accessed at the address www.fondazionecarloacutis.org.

This information does not regard other websites, pages or online services that can be reached via hyperlinks that may be published on the website referring to resources external to the Foundation.

Data regarding natural persons identified or identifiable may be processed when they access the website.

Data Controller and means of collecting data

The Data Controller (*pursuant to art. 4, para. 7 of the GDPR, the natural or legal person, public authority, service or other body which, together with others, determines the purposes and the means of processing personal data*) is the non-profit organisation Carlo Acutis Foundation (hereinafter the “Foundation”), with registered office in Via Don Minzoni 14 – 10121 Turin.

Legal basis of processing

The personal data (*pursuant to art. 4, para. 1 of the GDPR, any information regarding an identified or identifiable natural person*) indicated on this page are processed by the Data Controller for the execution of the contract, in the legitimate interest of the Data Controller (*art. 6, para. 1, lett. f) of the GDPR*).

Type of data processed and purposes of processing

Browsing data

During their normal use, the IT systems and software procedures used for the functioning of this website acquire a number of personal data, the transmission of which is implicit in the use of internet communication protocols.

This category of data includes the IP addresses or domain names of the computers and terminals used by users, the URI/URL (Uniform Resource Identifier/Locator) addresses of the resources requested, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the operating system and IT environment of the user.

These data, necessary for using the services of the website, are also processed for the purpose of:

- obtaining statistical information on the use of the services (pages most frequently visited, number of visitors per time slot or day, geographical origin of visitors, etc.);
- verifying the proper functioning of the services offered.

Browsing data are not retained for longer than 0 days (unless the legal authorities need to do so in order to ascertain whether an offence has been committed).

Data provided by the user

The optional, explicit, voluntary sending of messages to the contact addresses of the Foundation, the private messages sent by users to the institutional pages/profiles on social media, and the filling out of forms requesting data involve the acquisition of the sender's contact data, which are necessary to respond, as well as of all the personal data included in the communications.

Specific disclosures, drafted for the provision of particular services, will be published on the website of the Foundation.

Cookies and other tracking systems

User profiling cookies are not used on this website, which does use session (non-persistent) cookies - exclusively for the purposes of guaranteeing safe,

efficient browsing on the website – and statistical cookies, which help website owners understand how visitors interact with the website, by collecting and transmitting information anonymously.

You may, at any time, view the cookies used by our website, and amend or withdraw your consent by accessing the “Cookies” link on our website.

Data recipients

Pursuant to art. 28 of the Regulation, the following subjects appointed by the Foundation are recipients of the data collected following consultation of the website, in their capacity as external Data Protection Officers:

- Crispy Bacon s.r.l., in its capacity as a provider of web platform development and maintenance services

The personal data collected are also processed by personnel authorised by the Foundation, which acts according to the specific instructions provided regarding the purposes and means of processing.

The personal data may also be made available to supervisory bodies, police forces and the magistracy, by virtue of laws or regulations that require their communication for the carrying out of their institutional activities.

Transfer of data to third countries

To provide the services offered, the Data Controller uses servers located outside of the European Economic Area.

Means of processing of personal data and data retention period

All the data collected are processed in observance of the principles of lawfulness, correctness and transparency, for specific purposes notified to the data subjects at the time of collection, using technical and organisational tools suitable to minimise processing and to guarantee the accuracy, completeness and confidentiality of data.

The Data Controller processes personal data with manual, IT and electronic tools used by its employees and workers authorised for the purpose. Processing is carried out by applying the necessary technical, organisational and physical safety measures.

Personal data will be retained for the time necessary to perform the activities related to the purposes for which they have been collected, as described in this disclosure, and to comply with legal obligations.

At the end of this time, the data will be deleted, or, if maintained for statistical purposes, irreversibly anonymised.

Rights regarding data

Data subjects have the right to know, at any time, if personal data regarding them

are being processed, and if so, to request access to them and obtain information on the purposes, the categories of data involved and the recipients they are transmitted to, the data retention period and how this period is established, and the origin of the data.

If the legal grounds therefor exist, you also have the right to request the correction of your personal data (if they are inaccurate) or their deletion (not possible to the extent to which processing is based on compliance with a legal obligation), or to obtain a restriction of processing. You may also exercise the right to object in the event of processing based on legitimate interest.

Data subjects may request the portability of data onto a structured, machine-readable format, as well information on the origin of any data that have not been collected directly from the data subject.
